- -The above assessments were selected for use as they were completed by the whole cohort, following a standardised programme of revision.
- -Assessments 2-5 were taken during a period of minimal disruption (Assessment 1 was impacted by some minor bubble closures but most pupils were able to sit the test.
- -All assessments were based on past papers or exam board SAMs with AQA mark schemes allowing for appropriate standardisation of marking.
- -Together they cover aspects of all three papers and all Assessment objectives are covered.
- -Grade boundaries used were a mean of 2018,2019 and 2020 with NEA removed.
- -Once the grade was generated using a cumulative mark, these grades were then checked against the grade descriptions provided by OCR and holistic historic performance on assessed pieces of work before a final grade is allocated.
